FIRE PREVENTION OFFICER REPORT

To All Householders of the K.I.B.: As Fire Prevention Officer for the Kamloops Indian Band, it is my responsibility to assist you in making vour home as safe from fire as possible. The losses of property and deaths created by fire in the home in B.C. has reached alarming proportions most of which are totally unnecessary, caused by carelessness, ignorance of the installation and safe use of heating appliances and flammable liquids, etc.

I am mainly concerned with propane and oil tanks and furnaces and gasoline tanks as to whether they have been installed as per Fire Services Act Regulations. As many people are using wood burning heaters today to save on energy costs, I can advise you on the safe use and installation of these appliances. I will have some pamphlets on this subject very soon, put out by the Fire Commissioner's Office.

If you wish to have an inspection of your home, please fill out the attached form and send it to this office or phone 372-9575 and ask for the Fire Prevention Office and leave a message.

More Information On Fire Prevention

Stoves, Ranges, Space Heaters and Service Water Heaters Using Solid Fuel

1. Stoves, ranges, space heaters and service water heaters using solid fuel shall be installed in a room or space sufficiently large to permit accessibility to the appliance and to provide clearances as required in Table A and B.

- 2. A solid fuel heater may be mounted on any type of floor provided the heater:
 - a) is mounted on legs that provide a clear space at least 4 inches high, and
 - b) is of a type in which flame or hot gases do not come in contact with its base and provided,
 - c) that the floor surface of combustible material beneath the heater is protected by a layer of sheet metal over 1/4 inch asbestos for a distance of 18 inches beyond the appliance on the firing side and the side where ashes are removed, and extending at least six inches beyond the appliance on the other sides.
- 3. The minimum clearance between heater and combustible material whether or not such material is covered with noncombustible material such as plaster shall conform to Table A & B.
- 4. Clearance between flue pipes and unprotected combustible material shall be not less than 18" except that where the flue gas temperature does not exceed 750 F, the clearance may be reduced to 9 inches. Where 18" clearance is required, it may be reduced to values shown in Table C where combustible material is protected.

Dear Mr. Minister:

Through the local press and in discussions between our offices and those of the Mayor of Kamloops, it has come to our attention that the City of Kamloops has approached you recently in reference to claims of unfair competition between the Band and the City of Kamloops regarding our Industrial Park Parkland and various business enterprises in which the Band is involved.

As you may know, the Band has the largest Industrial Park in Kamloops and has recently obtained a low interest loan from the B.C. Ministry of Economic Development to expand the park by an additional 76 acres. With our own monies we hope to upgrade water and roads on the existing site. In addition, the Band is in the process of discussions with the Provincial Ministry of Highways, concerning a third cross-

ing access to the Reserve for local highway traffic.

In the Industrial Park, the Band indirectly employs about 400 non-Band Members who live, trade and are taxpayers in Kamloops. We therefore feel that our development not only enhances the Band as a whole, but also adds to the economy of the Kamloops area and in particular the City of Kamloops. The long term intent of our economic policy is to improve the lifestyle and standards of our Band Members and make us less dependant upon the Provincial and Federal Governments.

The position of the Mayor and Members of Council of the City of Kamloops (who have recently been able to get the local Chamber of Commerce support) is one of opposition to our economic endeavors.

On another front the Band is taking strides in establishing itself as local Indian Government. Steps in this direction are:

- a) Bylaws under Section 83 of the Indian Act to regulate Band Affairs,
 Land Use, Pollution, Housing and
 Building Standards, Fire Prevention
 Taxation, Trespassing and Election
 Matters. (Some of these bylaws are
 in place, others are at the second
 reading or draft stage and require
 input from Band Members.
- b) Negotiating with the Provincial

PRESS RELEASE (Continued)

- b) Government to relinquish Taxation Authority on the Reserve so that we can implement our own taxation bylaws. (This would avoid double taxation problem for our lessees).
- c) Discussions with Regional D.I.A. Officials to have the Band assume more control over Band Lands under sections 60 and 83 of the Indian Act.
- d) Assumption of most social programs, through local services agreements, from D.I.A.

The City of Kamloops also appears to be opposed to this thrust also as it would establish an almost parallel local government level to their own. As we become more competitive, the City raises increased objection to our enterprises. The recent position, is that the Band be put under the planning umbrealla of the City of Kamloops. The Band, through the Thompson Nicola Regional District and the Provincial Government is working to meet provincial pollution and land use standards. (Something we might add that has not, in total, being done by the City of Kamloops).

History could be repeating itself, the Band was forced to amalgamate with the City from May 3, 1973 to to March 16, 1976. With a change in provincial government in 1975, the Reserve was removed from the City. During this period, it was estimated that approximately \$400,000.00 was levied in taxes on the Reserve by the City with less than \$16,000.00 being returned in services to the Reserve.

The Band not only feels that it does not want to repeat the tax enquities that were experienced during amalgamation, but does not want to be put into a situation where it would be controlled by its competitors.

As a result of the Band attempting to improve its competitive edge in the market place, the City of Kamloops has "pulled out all the plugs" in an attempt to stop our development. One of these has been, as you know, to approach yourself. On future meetings with your offices and a third party concerning the Band, the Band would like to have knowledge of the meeting and have a representative present. Thank you.

I hope that this has provided you with some backgroud on our local problems should you require any additional information please do not hesitate to contact us yourself.

DROP IN CENTRE


As you know the Centre will be opening again soon; so I'd like to ask all you good people, if you have any old games or magazines and such could you please donate them, it would be well appreciated.

PROGRESS ON SETTING UP LOCAL GOVERNMENT. BYLAWS.

The Band has passed three administrative Bylaws which are the first step in writing into law procedures for the internal operation of Band Affairs. These are the first in a series of required to establish a local government operation. Kamloops is the first of several Bands in B.C. to set up these procedures. Copies of these bylaws are available at the Band Office for Band Members. They are as follows:

A) Appointment of a Band Administrator Bylaw

This bylaw lays out the duties and responsibilities of the Band Administrator and procedures by which he/she is to execute their position.

B) Procedures of Council Bylaw

This bylaw lays down the procedures of Council Meetings and lays out guidelines for Council Meetings, Committees and prohibits Councillors voting on issues that are considered a conflict of interest to them or their immediate family.

C) Financial Procedures Bylaw

This bylaw lays out the financial procedures and requirements that are necessary to properly control all funds that are handled by the Band. This bylaw ensures that full accountability and proper handling of monies is to be conducted in the interest of Band Members.

BAND PLANNER

The Band has successfully negotiated a contract with the Department of Indian Affairs to hire its own Band Planner. The Band Planner will work with the Planning Committee and Band Administrator to update Planning materials that are available from previous planning studies that have been conducted with the following priorities in mind:

SCHEDULE I - WORK PROGRAM FOR BAND PLANNER AND COMMITTEE

The Work Program is to involve sever projects until March 31, 1981.

The Projects are priorized and will be scheduled according to the dates included herein. Although these dates are target dates, much will depend upon the skills of the Band Planner. The projects are as follows:

PRIORITY #1

A complete review of the Band Land Administration facilities of the Kamloops Band and a detailed plan of policy and administration requirements that must be met to:

- a) facilitate the expeditious marketing of leases.
- b) facilitate the assumption of administration powers of the Band as required under section 53 and 60 of the Indian Act and develop draft policies.

PRIORITY #2

Develope a marketing strategy for the marketing of our expanded subdivision (Mt. Paul Estates) This will not be an overly onerous task as the preliminary study has been completed and is being updated. The project will involve one of two options. (To be decided).

a) A method of sales promotion by the Band,

or,

b) A set of guidelines for a outside agent.

BAND PLANNER (Continued)

PRIORITY # 3

The establishment of comprehensive program to introduce Shuswap History, Language, and the development of a museum on Reserve which will be co-ordinated. Much work has been completed in this area by the Bands Education, Library and Land Claims Committee. An assessment of work to date would have to be made, a review of available resources, and plans of future funding and curriculum development and physical requirements completed in details.

PRIORITY # 4

Range Program

A preliminary review of the B.C. Ministry of Agriculture has been completed this year. A more indepth inventory and assessment of range potential is to be completed and a comprehensive program of both on a physical sense and management sense must be completed and submitted for implementation by range crew.

PRIORITY # 5

Physical planning for Residential/ Agriculture subdivision. This area is east of the school and has been surveyed into 32/10 acres lots for Band Members use. A five year program for supplying water both domestic and irrigation, as well as infra-structure has been completed This plan will be updated and greater cost detail should be included to meet resident needs.

PRIORITY # 6

Employment Development. This project will be integrated with all additional band activities and should run concurrent with other priorities. An inventory of skills and Band Members training must be obtained. Economic Development projects and Manpower re-

quirements for the next five years to be estimated. Training programs, placement services and other relative services should be inventoried and then an approach using existing systems and future requirements developed. The program should be a minimum of five years projection with recommendation on better utilization of recources.

PRIORITY # 7

Review of water system use. This program will review all new and existing domestic water requirements. Some of this activity will tie in with priority #5. The Band has five water systems. Some are dependent upon water shed systems and a plan for preserving it as well as upgrading the natural and man-made components must be completed to protect the health of Band Members. It is expected that this plan would meet Band and Health and Welfare objectives.

PRIORITY # 8

A plan to establish a volunteer Fire Department in colloboration with lease holders on the Reserve. Much equipment is purchased to date and much expertise on fire department administration is available through our fire inspector.

NOTE: One of the task of the Planner will be to outline and draft necessary bylaws, when needed to effectively match a program.

The Planning Program will be over a 16 month period. The Band, will shortly advertise for a native person to act as planner and to be backed up with professional assistance. The employee will be a para-professional with some planning background. He or she will be holding workshops with Band Members on many of these topics to get their input and ideas.



RESIDENTIAL SCHOOL

The Band has successfully completed negotiations with Cariboo College to take over the Residential School. This involves the Red Brick Building and the annex. The pool, gymnasium, "teck" and other buildings stay with the Band. The College is expected to move into the East Wing of the School on January 1, 1980. It hopes to take the remainder of the school by September 1, 1980. The use of gymnasium and pool, fields, etc. will be co-ordinated through separate agreements so that the Band can also use the facilities as well as the college. The college agreement for the buildings is for five years with the Band. The College expects to spend about \$250,000.00 on inside renovations over the five year period.

ADMINISTRATOR AGREES TO STAY ON UNTIL AUGUST 30, 1980

The Band and the Administrator have reached an agreement for the Administrator to remain with the Band until August 30, 1980. The original agreement was for a two year period which ended September 15, 1979.

LOCAL GOVERNMENT ORGANIZATION

Over the past two years the Band has through several stages been able to reorganize to meet the needs of local government. By April 1, 1979 the Basic Organization framework will be completed. Staff Training both (on the job and classroom) will continue to bring more Indians into the organization in key positions. By April 1, 1979, the Band Organization will look like this.
