- If you are applying for a refund pursuant to section 13 of the PTT Law, please complete PTT Form #3, attach sufficient evidence to demonstrate entitlement to the refund, where applicable, and attach the completed Form #3 to this Application.
- If you are applying for a refund for any other reason, please attach all relevant documentation to demonstrate entitlement to the refund to this Application.
