Tk'emlúps te Secwépemc (TteS) is a fast-growing vibrant organization committed to the development and progress of its Band Members and Community. As such, the TteS invites applications from qualified, highly motivated and dynamic individuals to fill the following position.

NATURE AND SCOPE OF WORK:

Homemaking services are limited to the list of household tasks required to maintain a safe and supportive environment. Homemakers work in partnership with the Qw'emtsin Health Society, as directed by the Community Health Representative. Homemaking services supplement but do not replace the care provided by families.

DUTIES:

- Homemakers must report emergency concerns immediately to CHR verbally and with a written incident report.
- Homemakers will check in remotely due to COVID 19, and will be expected to report in each morning by 8:00am, via text or calling in.
- Keeps Community Health Representative informed regarding client progress, noting client improvement or deterioration of ability to perform daily tasks;
- Attends Community Services staff meetings when requested to do so; and
- Abiding by the strict guidelines of TteS COVID protocols & procedures
 - Temperature checks of all people within the residence
 - Thorough sanitization of common areas
- Services provided by the homemaker include, but are not limited to:
 - Cleaning bathroom, sink, tub & toilet
 - Dishes
 - Dusting
 - Light meal assistance
 - Light housekeeping. This excludes biohazardous materials (i.e. bodily fluids/waste)
 - Garbage removal
 - Laundry
 - Sweeping, vacuuming, mopping floors
 - Washing inside windows

REQUIRED COMPETENCIES:

- Knowledge of Indigenous culture and individual traditions
- Working with Elders

- Excellent communication skills
- Upholds client confidentiality
- Working with medical and palliative patients
- Homemaking experience or janitorial experience
- Demonstration of tact, patience and respect for all clients
- Ability to work independently without direct supervision

MUST HAVE:

- Criminal Record Check for Working with Children and Vulnerable Adults – clearance required;
- Valid Class 5 driver’s license, own reliable transportation and the ability to be insured; and
- Clean drivers abstract.
- COVID 19 orientation of protocols & procedures required.

ASSETS:

- Homemaker Training or equivalent;
- First Aid Certificate; and
- Food Safe Certificate.

HOURS OF WORK: Normal day shift – 7 hours per day. Non – normal shift may be required.

PAY GRADE: \$14.60/hour
