Position Overview

Safely operating mill processing circuits to meet production targets.

Key Responsibilities

- Operating and monitoring various circuits in the processing plant as required by the supervisor. Circuits include: Control room, Grinding, Flotation, Dewatering and Tailings.
- Develop an understanding of all the mill circuits through training, reading, and hands-on experience.
- Identify maintenance problems and maintain acceptable housekeeping in designated area.
- Dedication to safety, equipment care, and the environment.
- Operate mobile equipment and overhead crane as required by their particular circuit.

Qualifications

- Grade 12 Diploma or equivalent required
- 6 months mineral processing and/or 2 years milling and/or 4 years industrial experience required
- Experience as a leader is highly desirable

- High mechanical aptitude
- Valid driver's license with access to personal transportation
