Tk'emlúps te Secwépemc("TteS") welcomed Taysia Fraser & Peyton Anderson the inaugural intern secondment with Qwelmínte Secwépemc("QS"). Taysia work with Dan Klassen, Referrals Officer and other employees in the Natural Resource department. This gave her work experience in the field and connection in community. Peyton worked closely Shannon Squire, TteS's Intergovernmental Affairs Analyst. Peyton observed the dynamics of a well-run Indigenous Government by supporting regular Chief and Council Meetings though meeting notes, correspondence letters, reviewed and edited documents. Major project for the summer was streamlining a modern filing system for all documents and portfolios.

#### **BCAFN Resolution to Support the QS Knowledge Builders Program**

Kukpi7 Rosanne supported the at the BCAFN resolution, Respecting Indigenous Law & Building Capacity for our Next Generation to walk in Two-Worlds. The QS Knowledge Builders Program focusses on the next generation of leadership and capacity building that standing up Secwépemc Language, Law & Governance. The resolution was passed. Be resolved that the chiefs in assembly:

- Support the development of capacity building and knowledge builder programs ... Indigenous Peoples and groups ... consistent with the UN Declaration and through Government-to-Government relations.
- Call on the Government of BC to direct its Declaration Secretariat to work directly with Qwelmínte Secwépemc secretariat ... to scope the development of a 'Walking in Two-Worlds' knowledge Builders program in order to support the implementation of the Declaration Act and its Action Plan.
- Call on the Government of BC to work in full collaboration with First Nations, ... consistent with the UN Declaration and fully supported by capacity building initiatives, such as the TeamSkú7pecen Knowledge Builders Program.
- Call on the Government of BC to work in full collaboration with First Nations, ...recognized and accredited through the Provincial education systems and institutions.
- Support the Qwelmínte Secwépemc in sharing information and knowledge regarding the TeamSkú7pecen Knowledge Builders program with interested Indigenous groups and organizations.

- Christmas Hamper delivery
- Hired Community services Manager April 2022
- Elders- Elders Trip in July 2022 to the Papal Visit in Alberta: Hobbema, Alberta - Ermineskin Cree Nation, Edmonton, Alberta Edmonton, Alberta and Lac St Anne, Alberta was a success. There were 20 Elders on the trip.
- Started the Elder monthly luncheons and birthday celebrations. Elder Luncheons were started up again in the summer of 2022.
- Elder Christmas Dinner was a huge success. There were 80 Elder's present for the Christmas Dinner.
- Provincial and National Elder Gatherings preregistration has commenced.
- Cultural Enrichment Worker hired, Steve Basil was hired and now works with TteS community and Youth within community.
- Community Engagement and Sharing Circles have begun with the Cultural Enrichment.
- Possession Acquisition License (P.A.L.) courses are now beginning with 2 secured dates of training. An additional course will be added with the amount of interest in the training.
- Preparing for Hunting, Fishing, Berry Picking, Food Processing, Cultural Camps has commenced.
- Food Sovereignty: Food processing, canning, baking, gardening, and green house have all started with a compliment of 4 staff members working on the project.
- Green House on Kamloopa Way is in operation. Hot House and Berry Walk have also been completed and are in use.

- Food processing workshops are being held. Both male and female adults are participating in the workshops.
- Membership Code (Indian Registry Administrator)
   13 Grassroot meetings Committee Members and
   Arbitration Board names have been selected. Waiting
   on 3 families to have completed their representatives
   which will finalize the Representative lists.
- Membership Code Worker position is in process.
   Training will commence shortly after the Committee and Board positions are filled.
- Sports and Recreation: The Youth Centre is now open full-time Monday thru Fridays. After school youth groups are open.
- Teen Nights is held on Monday and Wednesdays. 2B Boys and Girls are held on Thursday evenings.
- Outdoor Club: Skiing, Snow Shoeing are now open.
- Summer Camps were open during the summer:
   Swimming, biking, canoeing, mountain biking, cruisier
   Bikes program.
- Moccasin Mile walk/run programs had started.
- Community Parties are now happening. Halloween, Easter and community Christmas dinner were held.
- Indigenous Day, Remembrance Day and Community Christmas Dinner were all successful.
- Justice Worker has now started on full time basis. Reviewing material that was previously available. Preparing new material with new programs and services that are now available. Meeting with the local Police.
- Child and Family Support services are at capacity and will be recruiting additional staff shortly. Case- loads are full capacity to caseload standards. Additional funding was provided from ISC for Prevention Programming. Planning is underway for the Prevention Programs and Services with the additional funding received.
- Stsmemelt Coordinator FTP was acquired last fall.
   Community Engagement Sessions are now being held to inform the community of Stsmemelt and to gain community input.

- Stsmemelt Coordinator attended the Summer Gathering held at 100 Mile House, which was a success. The Stsmemelt Coordinator was able to provide gift cards for travel and meals for the TteS community members who wanted to participate in the Summer Gathering.
- Health: CHR has created and updated the Health Dept. programs and services:
- Community Health Dept secured a FTP Community Services Funding Assistant
- Essential Services Driver was secured and will be acquiring an additional driver.
- Staff were provided with Mental Health First Aide Training

- Homemakers work with the community to assist the Elders, people with disabilities with Home Care.
   Additional Homecare providers will be required to complement the current Homemakers.
- Assistance to TteS members' mandatory medical/dental application with Non-Insured (Pacific Blue Cross) is provided.
- Personal Wellness Calls are made to community members that maybe in need. (New service)
- Medical Equipment Loan Program was also created to assist TteS community who require medical equipment i.e.. (wheel chairs)
- Development of Mental Health & Wellness Program handout completed this year with Le Estcwicwéý Dept.
