Position: Casual Direct Support Worker for Children and Youth in Care of the Child Welfare System

Geographic Catchment Area:

Kamloops and surrounding area which is located in the unceded territory of the Secwépemcul'ecw.

Reports to: Michif Child Safety Case Manager

Position Overview

The Direct Support Worker provides culturally safe and trauma informed one-to-one support to Métis children and youth in care who require additional support. The Direct Support Worker follows the direction of and reports to the child/youth's delegated social worker in a manner in keeping with the child/youth's care plan and the LMO Michif Practice Model. Hours vary on the needs of each child/youth. The Direct Support Worker must be skilled at:

- Building relationships with vulnerable populations who have experienced multiple broken relationships
- Responding to crisis and de-escalating challenging situations
- Creating opportunities for spiritual and cultural connections such as visits with Elders, access to traditional medicines, resources, healing practices (i.e.: smudge, sweats, drumming circles, etc.)
- Supporting hands-on life skill development (i.e., cooking meals together, organizing living spaces, developing and implementing daily routines, etc.)
- Facilitating healthy relationships with siblings, parents, extended family and peers
- Active and compassionate listening
- Change management
- Completing daily documentation and reports
- Works as a positive and supportive member of our Michif Team
- Performs other duties as required.

Qualifications:

- Completion of a Bachelor's Degree or Certified Diploma in the field of human/social services. A combination of work experience and education may be considered.
- A minimum of one-year <u>related</u> work experience.
- Demonstrated experience working with hard-to-reach, vulnerable populations
- Demonstrated experience delivering culturally safe services and working respectfully with Indigenous Peoples
- Demonstrated knowledge and experience with Indigenous cultural practices, protocols and ways of healing.
- Demonstrated ability to work independently with minimal direct supervision
- As per Section 16 of the Federal Charter of Human Rights Act, preference will be given to applicants of Indigenous Ancestry.

Working Conditions:

- Works in partnership with all branches of our Michif Team including Elders.
- Potential for violence in the workplace
- Ability to perform the requirements of the job which include working independently with Indigenous
 youth who may experience cognitive delays and/or challenges with substance misuse, mental health or
 other trauma related behaviours
- Travel within Kamloops and surrounding area will be required

• Responds to rare after-hours or emergency calls

Conditions of Employment:

- Must be able to obtain and maintain a Criminal Records Check
- Must be able to obtain and maintain a valid BC Driver's License and Driving Record
- Must provide a vehicle in good operating condition and appropriate vehicle insurance to meet program requirements
