



VOTING INSTRUCTIONS FOR 2021 CER AMENDMENT VOTE:

Online Voting: May 11th, 2021 – 8:00am to 6:00pm

Online voting will take place via Teams meeting. There will be multiple meetings, divided alphabetically by last name, and the links for the meetings will be posted to the Tk'emlúps te Secwépemc website and Facebook page 24 hours before online voting opens.

For instructions on how to sign in to a Teams meeting, please see the Instructions for how to Join a Teams Meeting handout.

Before you sign in to vote, please:

- check that your camera and microphone are working for your computer, tablet, or cellphone;
- have your photo ID and Band number available; and
- have a copy of the Proposed Amendments to the CER on hand for your reference while voting.

How the online vote will work:

1. Join the meeting link corresponding to your last name. The meeting hosts will be notified that you are in the waiting room.

2. The meeting hosts will let one person in at a time.

Please be prepared that there may be a virtual line-up and depending on the number of voters that are voting you may have to wait in the waiting room for a period of time before being admitted to vote.

3. You must have your camera on and be in front of your screen when you are admitted to the voting room.

Please note: If you are admitted and you are not in front of your screen, you will be disconnected from the meeting, you will lose your place in line and will have to re-join the meeting to vote.

4. The TteS representative will verify your ID and mark you off on the voting list.

5. The Forward Law representative will direct you towards the Meeting Chat where you can vote “yes” or “no” for each of the 25 proposed amendments. The vote count below each amendment vote will show that you have voted, but your vote will not be displayed.

6. Once you have submitted your vote on all 25 amendments, you will be asked to leave the meeting.

If you have any trouble or questions about how to submit a vote, the Forward Law representative can assist you, but you will not be able to ask questions about the content of the vote.

DO NOT TYPE ANY MESSAGES INTO THE CHAT BAR AS IT WILL BE VIEWED BY ALL SUBSEQUENT VOTERS.

Paper Ballot Voting: May 12th, 2021 – 8:00am to 6:00pm

In-person paper ballot voting will be held on May 12th, 2021 at the Moccasin Square Gardens. The paper ballot voting will be done in a similar manner to the vaccinations, with a one-direction flow through the space and separate lines, divided alphabetically by last name. Upon arrival, please head to the entrance corresponding to your last name and maintain a safe 2m distance from the other voters. Masks are mandatory.

What to bring with you:

- Your photo ID and Band number; and
- A copy of the Proposed Amendments to the CER for your reference while voting.



There will be 25 votes on the ballot, one for each proposed amendment. Clearly vote “yes” or “no” on each proposed amendment.

Once you have completed your ballot, you will place it in the ballot box and leave through the Exit doors.
